Proposed Rule Change 8.04

NSTRA has a significant continuing problem of "unapproved" and "unregistered" dogs, unregistered and registered dogs with multiple owners and handlers identified for each record, and duplicated registered and unregistered dogs in the database. Currently, there are 1405 records of dogs on the "unapproved" dog list with creation dates of 2017 through 2021. Most of these dogs have earned placements; that dog record cannot be deleted because the dog record(s) is tied to and is an integral part of the data set of an existing field trial record.

Most of these records were and are caused by multiple trial chairpersons, in multiple regions, on multiple occasions, and with incomplete and incorrect data creating a "new dog" while setting up a trial rather than finding the correct and actual dog record in the system. Alternatively, there are many dogs with earned placements at trials and whose owners have never provided the proper registration to the national office to complete a dog record, so that a trial chair creates a new dog record for a submitted entry because they cannot find the exact dog they believe is the entered dog. In addition, many of the unapproved dogs in the database have changed owners, the owners are no longer NSTRA members, or for some reason office staff have been unable to resolve the record. Trial placements are supposed to be withdrawn when a dog does not become "approved" as per NSTRA Rule 8.04(c). This remedy is draconian. Because of this, it has been a rare occurrence and staff spend countless hours calling, emailing, and reminding members to get the registration into the office. Further, trial results should A dog must be eligible to be registered not be approved and finalized until all placing dogs within the trial are approved as per NSTRA Rule 8.04(b). However, the impact of not approving entire trials has other consequences that affect many more members and other necessary reporting in the organization.

During the last two years, office staff and at least one volunteer have tried to address the multiple records and reconcile the database. National Officers have specifically addressed Region Presidents about this issue at each of the last four National Board of Directors meetings. And yet, the list

continues growing with no resolution. A rule change was submitted to the National Officers as per NSTRA Rule 7.01 and Rule 7.02. This rule change was submitted to the National Rules Committee for review. The National Rules Committee determined that the rule was not necessary because the enforcement mechanisms in the existing rule were sufficient when applied. The National Officers decided to present the rule change and the committee recommendations to the National Board of Directors (BOD) because of the on-going nature of the problem an its impact on staff and NSTRA business. The BOD discussed the issue at length when presented with the rule change and the recommendations. As per NSTRA Rule 7.03, the BOD voted that the rule change be submitted to the general membership for a ballot vote.

A ballot is included in this issue of the NSTRA magazine. All regular members and Life members may vote. You may make photocopies of the ballot - - only one vote per regular or Life member number. Those with active functioning emails will receive a Survey Monkey ballot and may vote electronically in lieu of mailing, faxing, or emailing a hard copy ballot.

All ballots must be received by the date shown on the ballot or the date as directed by the electronic balloting system. All ballots will be verified for status of membership. The results will be published in the magazine and on the website. Rule changes are effective upon publication.

8.04 Current Rule

8.04 Proposed Change

NSTRA MEMBERS - Important things to remember!

Reminders - check back often!

National trials are the responsibility of the National Officers with input from the Board of Directors and the local co-chairs of national trials. Criteria for entry, which may be subject to change, for the original 5 National Trials is available in the reference section of the Rule Book beginning on page 41, Section 11. If a particular national trial is subject to changes in the entry criteria, there will be notice provided on the official entry form, in the magazine, on the national website, and/or by email if available.

To enter a national trial, you may submit a hard copy official entry form and payment, OR you may scan and email an official entry form with payment information, OR you may send by facsimile and official entry form with payment information, OR you may enter and pay on-line on the website. NO EXCEPTIONS.

Please note that additional new national trials may be added from time to time and do not yet appear in the current Rule Book. Please contact your National Officer Representative or the National Office staff for additional information regarding such trials. The current list of National Trials is as follows:

QUAIL FOREVER, formerly known as Quail Invitational. This is a revolving trial generally held in February.

TRIAL OF CHAMPIONS. This trial is held in Amo, Indiana, in April.

UKC PERFORMANCE TRIAL. This trial is a revolving trial generally held in June.

PURINA ENDURANCE CLASSIC.

This is revolving trial generally held in September:

DOG OF THE YEAR. This trial is held in Amo, Indiana, in October.

NATIONAL AMATEUR

CHAMPIONSHIP is a new trial (Dec 2020). The intent is to be a revolving trial.

TOP PERFORMANCE AWARD:

To be eligible:

*Dogs must have at least 20 open points accumulated in weekend trials between June 1 through May 31 of the applicable year. Once a dog is eligible, a schedule of scoring is applied based on the results at regional elimination trials and National Trials

*The Performance Trial will be the beginning national trial each year, even if it ends prior to June 1 in order to keep the number of national trials the same each year.

*The Regional Elimination trial results used in calculating Top Performance

Awards is the regularly scheduled regional elimination championship in the qualifying year/season (only one regional can count per year). Regionals scheduled or rescheduled to be held after June 1 will apply to the previous year. Each regional elimination will have a point value of 600 points. The value will drop 25 points per placement until the last dog or points run out (1 – 600, 2 – 575, 3 – 550, etc.). The placement for the regional eliminations is determined by the score of the last round in which the dog ran. In addition, 100 points will be awarded to the Champion, 75 for the second-place dog, 50 for the third and 25 for fourth

*The National Trials results are calculated as follows: A dog must place in the top 32 dogs to receive a qualifying score from that trial. Each national trial will have a point value of 800 points. The value will drop 25 points per placement throughout the Saturday cut (1 -800, 2 -775, 3 -750, etc.). The placement for the national trial is determined by the score of the last round in which the dog ran. In addition, 100 bonus points will be awarded to the Champion, 75 for second place, 50 for third and 25 for fourth.

HALL OF FAME NOMINATIONS:

Hall of Fame nominations will be accepted in a rolling calendar throughout the year. Send these nominations to the nation office, or to a national officer no later than March 31 of the year in which a dog is to be considered. Nominations of dogs to the NSTRA Hall of Fame are NOT "carried over" to following years. Plainly stated, a dog that does not get elected to the Hall of Fame in the year nominated must be re-submitted in order to be considered for election. The National Officers, in concert with the Board of Directors, make selections to the Hall of Fame each April.

TRIAL SCHEDULES:

Fall/winter trial schedules are due in the office by May 1. Spring/summer trial schedules are due in the office by Nov. 1. All trials must be published on the website 4 weeks prior to their running.

SANCTION FEES:

Trial sanction fees are required BEFORE a trial packet is mailed and before a trial may be "approved" in the system. Please pay all sanction fees at least 4 weeks prior to your trial date to ensure prompt mailing of the packet and to ensure that the trial may be drawn in a timely manner.

TRIAL REPORTS:

Trial reports and results should be entered into the trial draw system as soon as possible

after a trial and no later than 10 days after the trial date. Overall results will not be approved until the reporting is complete. First place points and championships will not be confirmed or awarded until the reporting is complete. (This includes receipt of all registration paperwork for placing dogs.)

HOME REGION:

Members requesting a change of Home Region must do so, in writing, through the National Office between the dates of October 1 and January 1. *Exception: A member who permanently relocates to within the boundaries of a Region, other than their Home Region, may make written application to the NSTRA office at any time to request a change in their Home Region.

ASSOCIATE MEMBERSHIPS:

Associate memberships are available to members' spouses and children 18 years and under, still living at home. There must be at least one regular paid membership in the household to qualify. Associate members have the same rights as regular members with respect to participating in field trials (e.g., owning dogs, handling dogs, judging, bird planting, etc.). Associate member may not vote in any regional or national elections including rule or by-law changes, they cannot hold an office, and they do not receive a magazine.

RULE CHANGES:

Proposed rule changes or new additions shall be submitted sixty (60) days prior to the first day of the Trial of Champions and/or the Dog of the Year trial.

CONSTITUTION/BY-LAW CHANGES:

All proposed amendments to the Constitution and By-laws shall be submitted to the National Officers at least ninety (90) days prior to the first day of the Trial of Champions and/or the Dog of the Year trial.

REGION HIGH POINT:

Points earned in the qualifying rounds of a Regional Elimination or a Championship trial DO count towards the region's high point competition. Points earned in the finals of above trials DO NOT count towards the region's high point.

OWNERSHIP CHANGE:

Once a dog takes a NSTRA placement, any subsequent ownership changes must be sent to the NSTRA office. Please send a copy of new registration papers with the new owners' names to the office. The date of transfer will be the date shown on the registration papers.


FIRST TIME PLACEMENTS:

The National Office now requires a copy of the dog's registration certificate for first time placements. This can either be submitted by the owner or the trial chairman. We will accept copies by fax

(317-839-4197), e-mail (office@nstra.org), or a photocopy by regular mail.

NSTRA DISTINGUISHED MEMBERS:

The NSTRA Distinguished Members award honors those extraordinary men and women whose contributions and achievements significantly helped develop, or continued to improve, the National Shoot to Retrieve Field Trial Association, Inc. This award will be presented annually at the Dog of the Year banquet. Nominations may be submitted at any time to the staff at the national office, to a National Officer, or to the current chair of the Distinguished Members Committee. A short description of the individual and their contributions to NSTRA should be sent to the national office. A picture of the individual should be included, if available. Contact the NSTRA office for a list of criteria. The committee will review all Nominations and verify contributions. Decisions will be made not only by the information submitted but by any other information collected. The committee will make their decision by the April Board of Directors' meeting. A permanent plaque will be located at the NSTRA office with a smaller plaque awarded to the individual or their family if deceased.

The Dog of the Year (October 28 – October 31) is a continuation of the regional elimination trials. This year was totally different because some regions had to cancel their regionals because of Covid19 and others postponed theirs until a few weeks before the DOY championship. Covid19 did not slow down the number of entries and the need for a dog competition with an outstanding finish.

Twenty-three regions were represented with 190 dogs running in three fields. There were 63 English Setters, 61 German Shorthairs, 38 English Pointers, 22 Brittanys, 5 German Wirehairs, and 1 Vizsla.

With Covid19, only one meal was provided to participants on Thursday evening which was a chicken and catfish buffet preceding the annual awards ceremony. Nance Ceccarelli was the chairman for the trial with assistance from JR Coke as co-chair and the president of the Conservation Bird Dog Club who hosted the event.

On Wednesday and Thursday, the top 16 dogs were taken from each field to advance to round 2. In round 2, the top 12 dogs from each field advanced to round 3 on Saturday. In round 3, the top 4 dogs advanced to round 4. In round 4, the top 2 dogs advance and the competition moved to field A for round 5 where the top 2 dogs advanced to the final hour.

Wednesday, the trial was blessed with a high of 52 degrees and no rain, but that did not last. Thursday, it was 50 degrees and Amo got about 1 inch of rain. Friday and Saturday were dry with cool temperatures. On Wednesday, A field started with field marshal Joe Dunigan (IN), judges Bob McCandless (KY) and Jerry Youmans (MW), and bird planter Michael Wayne (IN). TURNER

Jim Turner passed away on Sept.5, 2016. In addition to his wife, Pat he is survived by his son Mark (Elaine); brothers: Richard, Bruce, and Lane: three grandsons: Ben (Alicia), Jacob, and Sam; and one great grandson: Benjamin.

Jim grew up the 6th of 10 siblings on an 85 acre tobacco, cotton and vegetable farm in Oconee County, SC. At age 14, having decided he was not going to spend his adult life following the south end of a north bound

mule, he dropped out of school and moved 20 miles to Clemson. Jim worked with his oldest brother. Ervin, at his Gulf station pumping gas and checking oil, (for those under 40 that used to be a job).

While in Clemson he lived behind the service station in a repurposed beauty shop and met his wife-tobe, Patricia Sanders. Pat and Jim were married in 1956 and he fulfilled a wedding promise to Pat to finish high school by commuting to Oakway HS in a car he borrowed from Bill McClellan, a customer who would later become Director of Athletics at Clemson University. Jim worked at several other jobs and after graduation in 1959 rather than take a promotion with Belk's that required his leaving Oconee County, he began working at a local iewelry store. In 1960, Pat left her job with JP Stevens and joined Jim at the jewelry store. In 1963 they bought the jewelry store and Turner's Jewelers has since become one of upstate South Carolina's finest jewelers. More importantly he encouraged and recruited many members, both old bird hunters and young novices to come out and try NSTRA.



. Throughout the following years he systematically donated his resources to developing top notch fields and facilities for hosting NSTRA trials. Jim's legacy of support for NSTRA and the SC Region continues today through his Turner Family Trust. Jim loved his pointers especially when they did well or had placements. He carried to his grave the opinion that a find by a dog with a tail was worth at least 5 extra points but, if pressed, he might quietly concede that his best dog may have been a Brittany. Even though the placements didn't come as often in later years, Jim still looked forward to seeing and hosting his NSTRA family at Tokeena. As the sun was setting following a day of trialing Jim enjoyed gathering with friends, reliving the day's successes and failures, and raising a glass (aka a red cup) to another day enjoyed with the dogs. Thanks to Paige Lee for his beautiful tribute to his good friend, Jim Turner.

PENNY MONT-GOMERY

Penny Montgomery has been a lifetime member of NSTRA and the West Texas Region since 1992.

Penny was one of the first women handlers in NSTRA with an orange cowboy hat and orange boots. Penny is from the West Texas Region and a dedicated member. We all have stories to tell about "Miss Penny"! Mine might be a little different than yours but they always have the same focus. Friendly, outgoing, amazing, caring and happy! Miss Penny has been a member of NSTRA since 1992 and it all started with a promise and a dog. Penny promised her late husband that she would take their young setter, Grouse Jim's Will, get him trained and allow him to become the best dog he could be. 5 NSTRA championships later, her promise was kept. Later, Tomoka's Smokin Blu, would become one of NSTRA's premier dogs, A 15X champion with several national and regional trial placements including 2 Dog of the Year wins; Blu was elected to the NSTRA Hall of Fame in 2013. Wes Barr handled Blue throughout his career. Currently, Nathan Tekell runs Blu's Pepperwill Chloe, an own daughter of Blu, who has earned her NSTRA championship and a 2nd runner-up placement at the 2019 UKC Performance Classic. But Miss Penny isn't all about dogs and winning field trials. Raised in Arkadelphia, Arkansas she never lost her love for that area. She built a log house on the site of her grandparent's house and would travel there often with her friend, Brenda Barr. A former math teacher who learned to fly when it wasn't as common for women as it is now; she has flown all over the world, sometimes just to meet friends for lunch. A hunter, fisherwoman, pilot, scuba diver, dog handler, teacher......what else could there be?

She is a staunch supporter of NSTRA and her dog family. She has given much to the scholarship fund and is an encouragement to all, especially to the women who work and compete in this game. I came to work at NSTRA 12 years ago and to say I was overwhelmed with it all would be a gross understatement. At my first national trial (2008 TOC), I met her for the first time. She told me not to worry about the job and everything that went with it and that she just knew I would be fine. That really meant a lot to me at the time. Over the years, we have talked often and each time she tells a new story and I am always in awe of her accomplishments and kindness. She was so excited when she opened the letter that she was being awarded a Most Distinguished Award that she was overwhelmed. She said when life overwhelms her she just sleeps on it. Told me she was going to take a nap. Thanks to Julie Herwehe for her input regarding Miss Penny.

From Wes and Brenda Barr: Miss Penny is an incredible person. She has a love for God, Life and people that is beyond belief. She was a Honors Math teacher for many years and to this day many of her student still let her know how she inspired their life. She loved to golf and loved scuba diving. She loved Fly fishing. She booked a guide one year when we were in Montana at a National Trial. Invited me to go with her and we floated down the Madison river all day fly fishing. She was in a Bible Study Group for years. She was always taking it with her on trip to trials so she wouldn't get behind on her lessons. She was an avid and learned bridge player and played in a bridge group every week. She had friends all over the world. When she met someone

they were her friend for life and she always stayed in contact with them. Penny owned her own airplane and her flying group was a big part of her life. They all had planes and flew to difference places and met. I can remember her flying with the group to Alaska, New Zealand and Africa as well as many other places. Although Penny always had a smile and kind word her life had many trying moments. Most, probably too personal to her to share, but her attitude and service to others kept her going.

Attached is a file of information Penny wrote to be read at DOY in her absence since she was physically unable to attend. It's mainly about her first dog, Will and her beginning in NSTRA.

"Jim Montgomery's dream's dream of retiring after 32 years of working for his beloved EXXON had come true and we could build a house on the ranch in his home town of Moran, Texas. Quail were bountiful so predictably he developed a life long passion for keeping a birddog by his side and a shotgun in his hand (he was an excellent shot). We built our new home, brought his dog Snoopy and got a beautiful orange and white setter puppy, Happy. I could really walk then, so I got to follow Jim's training sessions everywhere. By then my natural competitiveness began to service so we bought me my first birddog and of course it was a lemon and white setter, Patches. At first I could still go with Jim and Happy but could not take Patches as he was too little. Then as he got bigger, I couldn't take him because he might interfere with Happy's progress. So, every time he left with Happy, I would get Patches and my gun (a wedding present to me from his boys as I was afraid of guns

until then) and we could go hunting for a couple of hours in the opposite direction. Thank the Lord Patches inherited the nose, stamina and patience with me along with everything he needed from his ancestors to be a great quail dog. My life changed from a teaching, golfing, swimming, tennis life to one that was exciting to me. However, it was a total reversal of my past, and I had to learn everything about West Texas life as I was being introduced to it. I had always loved dogs, but never hunted.

Patches would find and point half a dozen good covies for me and I would shoot and usually miss; we would then meet Jim at home and clean birds. We had a wonderful retirement life; two of is sons lived close and the third visited regularly and both my daughters and grandchildren were regular visitors. The First Christian Church in Albany played a big part in our lives and who could ask for anything more? Then the Ax fell. Ten year old Happy swallowed a large steak bone and it had to be surgically removed. The surgery was successful. And as Jim and I left for my flight physical in Abilene (My Cessna was in BKD and my annual physical was due) Jim called the Vet and he said Happy was making rounds with him because he felt so good and was so well behaved. When we returned from Abilene the phone was ringing and Jim answered. It was the vet and we learned Happy had turned septic and they could not save him. We were only gone about 3 hours.

Jim had an enlarged heart and a few days later could not breathe. The shock of Happy's death threw him into A-Fib. We spent several months in and out of the hospital, testing, doctoring, applying for a

hear transplant, being accepted and then waiting. The friend of Jim's whose Dad had taken Jim hunting as a young boy, showing him the "ropes" called one day and told him he was on his way to pick us up and take us to get Jim's new puppy. Jim assured him hat he could not even leave his chair in the daytime, but thanks anyway and after he got his new heart he would like to have one. James Shelton must have been parked in our driveway or close to it because it seemed like in no time he was there. We loaded up and drove to the puppy's home. Four adorable puppies were scuttling around the room and one was huddled under a chair closer to the center of the room stove (it was February and cold day). We watched them and visited a little, then I picked one up. Jim said "give me that pup"; I did and Jim instantly put him inside his favorite brown jacket with his head sticking out and the puppy stopped shivering. He just couldn't resist an aid; we would just take WILL home with us. I do not know where the name Will came from but I registered him as Grouse Jim's Will. Pee Wee Cole had horseback dogs and Will had plenty of run in him. The three of us were only together about 10 days before Jim's next congestive heart failure occurred. He had already planned for Roger Buddin to take care of him in Big Country Kennels if he had to stay in Dallas. Will stayed in Jim's lap in his chair ALL the time except when he ate or went outside. Will stayed the next few months with Roger as we had to stay in Dallas to be within 2 hours of the hospital when the new heart arrived – Will never got on any other piece of furniture but that chair, and he slept in it the rest of his life! Jim did not get the heart in time, and he passed on August 14,



1992. Can't you just see the HEAV-ENLY QUAIL HUNT Jim and Happy are having now?

It was several months before I picked Will up from Roger. I had taken Patches with me to Dallas and we were staying at Jim and Nancy's house while they were in Barcelona at the 1992 Olympics. Jim was the head Dr for the USA Teams When I picked Will up, Roger said he was a very talented dog and I should enter him in a NSTRA trial. Nasty what? I asked. No, National Shoot to Retrieve!!! I kept myself busy flying and I joined the Big Country Birddog Club so Patches and I could meet other quail hunters. I knew from being widowed before how horrible a time of loss that was and I must keep learning positive ways to keep active. Soooo, I told Roger to teach me how to compete in NSTRA. In the meantime Patches and I volunteered to guide for the Disability's Celebrity Quail Hunt which I found out about through Big Country Bird Hunters org. There may have been one other female guide at that time, I don't remember but anyway my only interest was in donating my time and quail hunts to DRI. WE guided all the airplane connections including Chuck Yeager and everyone was just wonderful to Patches and I.

RON HORN

Ron has been a member of the Arizona Region and lifetime member of NSTRA since 1986. During that time he has served as President of the Arizona Region, judging instructor, national and regional judge, and marshal. Ron also provides quail for numerous trials throughout the western states: the owner of Saddleback Game Birds Company. Ron has trialed many fine English Pointers and along with son Rod, has championed their fair share. Ron, along with wife, Patty live in Surprise, AZ and. Per Chris Cooperrider: Ron, as we all know, has been involved as a very active member of NSTRA for many years. I can personally attest to Ron's dedication to the ongoing success of our organization. I first met Ron at a field trial in northern Colorado about 6 years ago. Ron had delivered birds for our trial and was going to also judge for us. We had a storm move in that morning and Ron judged horseback in blizzard conditions all day without ever complaining once. From the day that I met Ron, I have been nothing but completely impressed with his attitude, willingness to share information regarding judging, handling dogs, training dogs, or about life in general.

Per Jerry Youmans: I know I speak for numerous other western NSTRA regions when I say that without Ron's help supplying birds and also judging, we would not have been

able to hold many of our past trials. Ron has driven thousands of miles delivering birds, risking his own well being on occasion, to make sure that he has birds delivered when he says. Around 1988 or 1989, the Northwest Region clubs were searching for an alternative to the current bird supplier, whose birds were not very good. I knew Ron raised and supplied birds to many regions. So we called and Ron supplied several NW clubs birds for our trials. First was when I was with the Snake River Sportsman and Gun Dog Assn. and then to the newly formed Clearwater Bird Dog Club. that I started with 3 other gentlemen. Ron delivered birds to Lewiston, Idaho from his operation in Arizona, and turned around without rest and made the return trip. He had other commitments for more of his birds. Once we heard he had wrecked near Salt Lake on a return trip; we asked if he and a partner would judge on a Saturday for us. That way we knew he would get some rest. Ron judged at least 2 or 3 trials for us after delivering birds. Even entering and running his dogs in our weekend trials after delivering birds. I have seen Ron Horn at many national trials over the years; he is always friendly and willing to spend some time catching up. I had not seen Ron in approximately 10 years and met him again at the 2017 Pike's Peak Trial near Woodland Park, Co. He supplied the trails' birds, and field marshaled on Friday. Ron is always the same; a great competitor, judge, field marshal, whatever role he's in, it's done with his heart and sole. Our thanks to Chris Cooperrider and Jerry Youmans for their kind thoughts of their friend.

Ronnie has five grandchildren – Harleigh, Bryce, Kaden, Brooklyn and Brandi who range in age from 21 to 14. He has been a teacher, a coach and an administrator prior to his retirement. He raises bobwhite quail and travels to the various states

as they need birds for their trials. I don't think he ever says NO to anyone! Ronnie is very dedicated and hard working with whatever tasks he is committed to. If the trial needs extra dogs in order to make a trial, Ronnie will put more of his dogs into the trial. He does whatever it takes for the association. He judges and holds judging seminars so others can learn how to be a judge. He bird plants, bring horses, enters dogs, volunteers to help in any way the chapter needs his help. He has many friends and they all know how loyal and devoted he is to NSTRA. His kennel is full of trophies won over the many years that he has trialed. He is honest and will always look at both sides of a disagreement before making a decision. He is a rule follower so everyone around

him had better know what the rules say before they disagree with a judging decision.

I can remember when he bought his first English pointer from a kennel in Mahia, Texas. He had researched the various kennels and decided that one would be the one. We showed up and the person in front of us paid around \$1500 for his dog. We looked at each other and wondered what we were going to do as we only had \$350 at the time. Luckily, we were able to purchase Bea. When the gentleman asked us where our kennel was for the dog, we just told him we were going to put the puppy in the backseat of the car with the kids because we did not have a kennel. I guess being naïve at some time is not always a

bad thing.

There are many stories that people could tell – bringing birds out of state to a trial in snow or rain; judging when no one else would, raising birds and learning how to do that with the many mistakes that were made along the way, being a loyal and faithful friend to many, never saying no to someone who needed help and being devoted to his family and his dogs!




