## **Letter from the President**



SPRING! is just around the corner and before you know it, regions across this country and Canada are trialing every weekend, regions conduct the culmination of the 21-22 trial season, and suddenly, the next trial season is upon us! An enduring cycle of traditions, progress, change, and reflection. We recently brightened your winter mailbox with the long delayed magazine featuring the 2020 National Purina Endurance Classic. After a lengthy fire and drought season last year, Lewiston received

"just enough" moisture in August to ensure NSTRA and Purina a successful venture among the Big Sky-MidNorth-Northwest regions and the King Colony. This magazine celebrates the 2021 National Purina Endurance Classic. Congrats to all!

If you've been around for a while and chaired a weekend trial or two, you may have noticed the evolution of trial reports from handwritten papers mailed to the office to an electronic system that records and tracks participant members, dogs, officials, scores, and earned points. As it was then, it remains the responsibility of the Trial Chairman/Trial Manager to ensure that this report is complete before submission. As it was then, we still receive many incomplete reports missing vital information. Although some have slipped through, the National Office staff are directed that they will NOT approve incomplete trial reports that sit in the queue.

The effect of chasing down incomplete and erroneous information is huge and prevents us from completing the multitude of tasks members expect. "Unapproved" trial reports impact reporting that triggers sending out CH certificates, lists for region high point, lists for eligible dogs for a regional CH, reports of eligible dogs for national trials, and data to track and qualify dogs for national awards. NSTRA needs YOU to properly complete trial reports.

If you are having difficulty obtaining information regarding a dog or a member, contact your Region President first. If you are having a technical issue setting up your trial or entering information during/ after the trial, contact National Secretary Nance Ceccarelli or National President Bill Sumpter – we can often help you out immediately during the evenings and weekends.

On a related note, unapproved dogs and expired members continue to plague reporting. All Trial Managers should double-check the "Details" tab in the lower left corner of your registration screen at three points in the process: when you setup the trial initially and begin to register dogs, before you attempt to draw the trial, and before you submit the trial after completing scores. What? You didn't know about the "Details" tab? This gives you a list of all expired membership of persons in your trial-including all officials and those "hidden" co-owners of dogs. If an official's credentials are expired, then you will not be able to select a "role" for that person.

The modifications to Rule 8.04 passed by a significant majority vote: 318 yes to 47 no. Previously, a dog only needed to be eligible for registry and we expected any placing dogs to provide paperwork to the National Office within 60 days or forfeit placements and points. This has not worked - -ever.



The National Officers decided to implement the rule beginning with the 22-23 trial season. **Beginning June 1st 2022, all dogs** must have registration papers on file at the NSTRA office **before** they can run in a NSTRA trial. Trial managers will no longer be able to enter a dog into a trial until the staff at the National Office create the dog record. The NSTRA National Officers and staff commit that all dogs' records will be created within one business day following receipt of the registration paperwork.

A couple of helpful tips: Submit your registration paperwork by USPS mail, fax, or email AND include a clear note of instruction that includes the dog's CALL name and the intended home region. If a dog is co-owned, ALL owners must be members of NSTRA. Documentation can be faxed (317-839-4197), emailed (office@nstra.org), or sent by mail (NSTRA, 203 N Mill St. Plainfield, IN 46168).

Some of us are noticing that when we look around at those running in trials, we realize that the time will come, sooner for some and later for others, when a good number of our members will no longer be able to compete. Now is a great time to introduce a new member to this wonderful game we enjoy. Take a person by the hand, show him what NSTRA is about, and help them through the "growing pains" we've all endured a-field.

This trial is traditionally held in February each year. All applications must be received at the national office no later than March 31, 2022. # NSTRA MEMBERS - Important things to remember!

#### Reminders - check back often!

National trials are the responsibility of the National Officers with input from the Board of Directors and the local co-chairs of national trials. Criteria for entry, which may be subject to change, for the original 5 National Trials is available in the reference section of the Rule Book beginning on page 41, Section 11. If a particular national trial is subject to changes in the entry criteria, there will be notice provided on the official entry form, in the magazine, on the national website, and/or by email if available.

To enter a national trial, you may submit a hard copy official entry form and payment, OR you may scan and email an official entry form with payment information, OR you may send by facsimile and official entry form with payment information, OR you may enter and pay on-line on the website. NO EXCEPTIONS.

Please note that additional new national trials may be added from time to time and do not yet appear in the current Rule Book. Please contact your National Officer Representative or the National Office staff for additional information regarding such trials. The current list of National Trials is as follows:

**QUAIL FOREVER**, formerly known as Quail Invitational. This is a revolving trial generally held in February.

**TRIAL OF CHAMPIONS**. This trial is held in Amo, Indiana, in April.

**NATIONAL AMATEUR TRIAL OF CHAMPIONS.** This trial is held in Amo, Indiana, in April.

**UKC PERFORMANCE TRIAL**. This trial is a revolving trial generally held in .lune

#### **PURINA ENDURANCE CLASSIC.**

This is revolving trial generally held in September:

**DOG OF THE YEAR.** This trial is held in Amo, Indiana, in October.

**NATIONAL AMATEUR CHAMPI- ONSHIP** is a new trial (Dec 2020).
The intent is to be a revolving trial.

## **TOP PERFORMANCE AWARD:**

To be eligible:

\*Dogs must have at least 20 open points accumulated in weekend trials between June 1 through May 31 of the applicable year. Once a dog is eligible, a schedule of scoring is applied based on the results at regional elimination trials and National Trials

\*The Performance Trial will be the beginning national trial each year, even if it ends prior to June 1 in order to keep the number of national trials the same each year.

\*The Regional Elimination trial results used in calculating Top Performance Awards is the regularly scheduled regional elimination championship in the qualifying year/season (only one regional can count per year). Regionals scheduled or rescheduled to be held after June 1 will apply to the previous year. Each regional elimination will have a point value of 600 points. The value will drop 25 points per placement until the last dog or points run out (1 - 600, 2 - 575, 3 - 550, etc.). The placement for the regional eliminations is determined by the score of the last round in which the dog ran. In addition, 100 points will be awarded to the Champion, 75 for the second-place dog, 50 for the third and 25 for fourth.

\*The National Trials results are calculated as follows: A dog must place in the top 32 dogs to receive a qualifying score from that trial. Each national trial will have a point value of 800 points. The value will drop 25 points per placement throughout the Saturday cut (1 – 800, 2 - 775, 3 – 750, etc.). The placement for the national trial is determined by the score of the last round in which the dog ran. In addition, 100 bonus points will be awarded to the Champion, 75 for second place, 50 for third and 25 for fourth.

#### HALL OF FAME NOMINATIONS:

Hall of Fame nominations will be accepted in a rolling calendar throughout the year. Send these nominations to the nation office, or to a national officer no later than March 31 of the year in which a dog is to be considered. Nominations of dogs to the NSTRA Hall of Fame are NOT "carried over" to following years. Plainly stated, a dog that does not get elected to the Hall of Fame in the year nominated must be re-submitted in order to be considered for election. The National Officers, in concert with the Board of Directors, make selections to the Hall of Fame each April.

#### **TRIAL SCHEDULES:**

Fall/winter trial schedules are due in the office by May 1. Spring/summer trial

schedules are due in the office by Nov.

1. All trials must be published on the website 4 weeks prior to their running.

#### **SANCTION FEES:**

Trial sanction fees are required BEFORE a trial packet is mailed and before a trial may be "approved" in the system. Please pay all sanction fees at least 4 weeks prior to your trial date to ensure prompt mailing of the packet and to ensure that the trial may be drawn in a timely manner.

#### **TRIAL REPORTS:**

Trial reports and results should be entered into the trial draw system as soon as possible after a trial and no later than 10 days after the trial date. Overall results will not be approved until the reporting is complete. First place points and championships will not be confirmed or awarded until the reporting is complete. (This includes receipt of all registration paperwork for placing dogs.)

#### **HOME REGION:**

Members requesting a change of Home Region must do so, in writing, through the National Office between the dates of October 1 and January 1.. \*Exception: A member who permanently relocates to within the boundaries of a Region, other than their Home Region, may make written application to the NSTRA office at any time to request a change in their Home Region.

## **ASSOCIATE MEMBERSHIPS:**

Associate memberships are available to members' spouses and children 18 years and under, still living at home. There must be at least one regular paid membership in the household to qualify. Associate members have the same rights as regular members with respect to participating in field trials (e.g., owning dogs, handling dogs, judging, bird planting, etc.). Associate member may not vote in any regional or national elections including rule or by-law changes, they cannot hold an office, and they do not receive a magazine.

## Important things to remember (continued from previous page)

#### **RULE CHANGES:**

Proposed rule changes or new additions shall be submitted sixty (60) days prior to the first day of the Trial of Champions and/or the Dog of the Year trial.

### **CONSTITUTION/BY-LAW CHANG-**ES:

All proposed amendments to the Constitution and By-laws shall be submitted to the National Officers at least ninety (90) days prior to the first day of the Trial of Champions and/or the Dog of the Year

## **REGION HIGH POINT:**

Points earned in the qualifying rounds of a Regional Elimination or a Championship trial DO count towards the region's high point competition. Points earned in the finals of above trials DO NOT count towards the region's high point.

#### **OWNERSHIP CHANGE:**

Once a dog takes a NSTRA placement, any subsequent ownership changes must be sent to the NSTRA office. Please send a copy of new registration papers with the new owners' names to the office. The date of transfer will be the date shown on the registration papers.

#### **FIRST TIME PLACEMENTS:**

The National Office now requires a copy of the dog's registration certificate for first time placements. This can either be submitted by the owner or the trial chairman. We will accept copies by fax (317-839-4197), e-mail (office@nstra. org), or a photocopy by regular mail.

### **NSTRA DISTINGUISHED MEM-BERS:**

The NSTRA Distinguished Members award honors those extraordinary men and women whose contributions and achievements significantly helped develop, or continued to improve, the National Shoot to Retrieve Field Trial Association, Inc. This award will be presented annually at the Dog of the Year banquet. Nominations may be submitted at any time to the staff at the national office, to a National Officer, or to the current chair of the Distinguished Members Committee. A short description of the individual and their contributions to NSTRA should be sent to the national office. A picture of the individual should be included, if

available. Contact the NSTRA office for a list of criteria. The committee will review all Nominations and verify contributions. Decisions will be made not only by the information submitted but by any other information collected. The committee will make their decision by the April Board of Directors' meeting. A permanent plaque will be located at the NSTRA office with a smaller plaque awarded to the individual or their family if deceased.

Effective June 1, 2022, "A dog must be registered with a recognized registry and registration sent to the **NSTRA Office** to enter any NSTRA trial". Be sure to get your dogs registered!

# 2021 PURINA ENDURANCE CLASSIC

If you have never gone to the Purina Endurance trial in Montana, you are missing one of the best national trials that NSTRA has to offer. The scenery is absolutely beautiful. This is truly God's country! The camaraderie is great and everyone in the Big Sky, Mid North and Northwest regions are available and willing to help. Whether we needed a snack from Jean's trailer, ice, and water for the coolers, or even toilet paper, they were ready to jump on any request we had. They also have the best meals served and the Hutterite's put on a spread that would rival any restaurant or even mom's cooking.

If you are new to NSTRA, the Purina Endurance trial uses a beat-your-brace mate format. To move on to the next round of the trial, your dog must score higher than its brace-mate. There is no waiting around, watching the scores. You know right away if you are moving on or not. Many members prefer this format as the scent and weather conditions are the same for both dogs. Your dog may score well but if your brace-mate scores higher, you are still out. That happened twice in this trial where the #1 and #2 top scoring dogs were braced against each other. The #2 dog took a placement but did not move on: Wednesday, B field and Thursday, B Field.

The trial is called Endurance for a reason. On Saturday, the top two dogs will have competed in four  $\frac{1}{2}$ -hour braces prior to running the final hour. This is three times the amount a dog runs in a weekend double. You and your dog had better be in pretty good shape.



Water of the West

Due to the severe drought conditions in the Lewistown area, and the toll the pre-trial took on the original trial grounds, we had to move the national trial grounds to a different area. The Hutterite's have a lot of ground available to use and Marvin and his crew worked hard to convert the alfalfa fields into trial grounds. Previously the grounds had been used as pasture area and unfortunately, they had to move a dead cow from B field. This is a first for NSTRA!

The new trial grounds were large. B field was 9/10 of a mile long. Luck would play in to whether you moved on or not. Whichever way you chose to go, there could be the possibility that your birds were few and far between. Jr. Coke usually puts about 35 miles on his ATV in a whole trial. He had 10.8 miles in the first 2 braces and 41.9 in 10 braces. Now imagine walking all of that!

This year's chairperson, Nance Ceccarelli, was extremely organized and the people she chose to work the trial managed their respective duties with ease. They knew their jobs, oversaw their responsibilities, and took charge when needed. It was an effective team effort!!!

The judges were Doug Cartwright and Dan Seliger from the Big Sky region, Stan Perdue from the Georgia region, Paul McCawley from the Northwest region. Field Marshals were Samantha Hight from the Northern California – Nevada region and Jean Steiner from the Mid North region. Bird Handler was Jr. Coke of the Indiana region. Trial Coordinators were Julia Herwehe from the Indiana Region and Ginger Rogers from the Arizona region.

**EDNESDAY** morning dawned clear and breezy. Good thing because it was going to be a hot day. After the National Anthem was played and the flag hoisted atop a John Deere tractor, the trial began. The wind picked up even more in the afternoon and it helped the dogs. They started finding more birds and many of the placements came from the middle of the day.



## In Memoriam Ray Hopkins


I remember the first time I met Ray Hopkins at a Championship Trial in Indiana, where he was judging the Championship venue. At that time, Ray was judging many trials. I believe John Verling was also judging with Ray. To make the story short, we had a good trial and great judging. I was very pleased to learn that Ray also ran dogs and judged in the Virginia Region each weekend. We became friends that week and remained friends throughout Ray's time with NSTRA and beyond. I believe that other than our founding fathers, Ray probably accomplished more for our sport than any other member ever has or will in the future.

I began marshalling championship trials when Lyle Jordan and Ron Robertson were in office. Prior to that time, I believe Lucy Duncan was the only woman field marshal. It was a great time for the sport, and I met many people, who became lifelong friends. For several years I marshalled most of the championship trials until one day I was asked to run for office. Bob had always said women should stay home and bake cookies; but after several guys came to him and gave their opinions, he relented and I ran for secretary. Ray was 1st vice-president at the time. Also there was an understanding that a National Officer could not be a trial official. So, Ray and Richard Savas invented the title of "Trial Coordinator," so I could do both jobs. My point in telling you all of this is to let you know that Ray Hopkins had my back from day one. He usually beat me to the trials and stayed behind me each day making sure rules were upheld and that I was doing the job correctly.

It wasn't long until Ray had the idea of a NSTRA database, which would replace and update our file system on 3x5 file cards. Tom Copella, a friend and co-hort of Ray's, worked with Ray and me to create a program that worked and worked well. After each trial, Ray would take what we had learned we were doing wrong to Tom; and they would work that week to make it better for the next. This cooperative effort placed us way ahead of our times as far as birddog associations.

For awhile, Ray was also over the Rules Committee, and he presided over that part of the BOD's meetings. At a later time, he wrote applications and interpretations for the rulebook, which are still intact today.

There were many other areas of NSTRA that Ray



Ray was 80 when he passed away peacefully on Thursday April 15, 2021 surrounded by his family. He was born in Little Rock, Arkansas on June 19, 1940 to the late Raymond and Mildred Hopkins. Ray later married Charlotte. his wife of 60 years who survives and children Jay, Sean Lee and Scott. He left 3 grandchildren Hailey, Sean Lee Jr. and Sadie and 2 daughter-in-laws, Dee and Katie.

Ray retired from the United States Navy as a Lieutenant, after serving for 20 years and in 2019, he retired from Civil Service. Not one to sit still, Ray had many hobbies including fishing, coin collecting, his gun and knife collection, working in the yard and on his grapevines and pedaling his bicycle hundreds of miles for the American Diabetes Association. Ray was laid to rest in the Veteran's Cemetery in Suffolk, VA.

Two epitaph's which were read on one item from Ray's funeral were as follows:

"The Happiest of people don't necessarily have the BEST of everything; they just make the BEST of everything that comes along their way."

"The measure of a man is not the NUMBER of servants he has but the number of PEOPLE HE SERVES."

Both hold true for Ray Hopkins, a servant of the United States, his family, and NSTRA. You are missed Ray. A true friend and colleague.

### **Beginning With the End in Mind**

My friend and I worked a trail in the grouse woods of Wisconsin. We left the trucks a mile back, and walked along the two-track while the dogs worked either side of the former logging road. The day was pleasant, but a bit too warm for the dogs. Temperatures in the 70's were nice for hiking or swilling margaritas on a beach, but for working dogs, it bordered on hot. October in Wisconsin brought warm and humid, or thunderstorms, or snow and sleet- or all the above, on any given day. The combination of Ruffed Grouse, thick forest, abundant hunting land, and good friends kept me coming back year after year in October- the finest month of the year. I had Shack (NSTRA CH/GA REG. CH Flyboy Ace's Bullseye (Brit/M)) on the ground, and he worked either side of the trail while we walked and talked.

Grouse hunting consisted of a long nature walk interrupted by the frantic rush getting to a dog on point, followed shortly by the roar of wings as a brown or gray bomber launched off the forest floor headed for safety. Today was no different, and as Shack crossed the trail, I gave him a blast from the whistle and extended my arm, pointing at a stand of trees 100 yards off the trail. He glanced up and took off in the direction I pointed, as we returned to our captivating discussion about the merits of ejectors versus

extractors. A minute later, my gps pager beeped, and I knew Shack was pointed. I turned and started walking with intention to the stand of trees, while checking my watch for his position. Sure enough, the dog was 67 yards away, on point. I learned, long ago, to move quickly to a dog pointing a Ruffed Grouse. Those birds will many times walk off under a point, until they reached a comfortable distance, and then the bird would flush away. We split up slightly as we approached, and my friend saw Shack first. He set himself up, said he was ready, and I walked toward the pointed dog, aiming for a point about 20 yards in front. The gray bird launched from behind a tree away from me, but it put him directly in front of my partner. It was a deadly mistake, as both our 28 ga. doubles barked at the same time. The bird tumbled onto he soft lichen floor under the planted pines. Shack was on the dead bird immediately, and made a good retrieve to my hand. I pondered the situation, and glanced up and my partner, "Nice shot!" I said, and I tossed the bird to him. "I'm pretty sure I was behind him. Besides, you shot just a split second in front of me. Your bird." He agreed. And so it went throughout the day.

The big Brit was near perfect that day, and my partner commented on it. "Thank you," I said. "He did have a pretty

good day." Shack, as an adult, was the culmination of years of learning from past mistakes. I learned to start training a puppy while still young with the end result always in mind. When they were just little puppies, fighting for the wet food, just weaned from momma, I would start quietly clapping my hands, and build up to louder noises over the weeks. They would associate loud noise with pleasure. I taught them obedience, whistle and voice commands, to recognize objectives, to retrieve with speed and style to hand (no dropping the bird early in the excitement), and steadiness on point regardless of shots, yelling, or ATVs roaring by. I taught them to back, and all the other little things that enabled a dog to compete in NSTRA. And, after all that, many trials, and a few hundred dead quail, perhaps by the age of two, I would load them in the back of the truck and we would head to Montana, South Dakota, Idaho, Oklahoma, or any number of other western states, and I would show them what a bird dog was born, bred, and trained to do. By the time Shack smelled his first wild bird, he already had a solid base of what it meant to be a bird dog. It wasn't a stressful time at all. I already knew how he would do, because for two years I trained him with the end in sight.

It wasn't always that way. My first dogs were a Brit male and a female Setter. I was learning about bird hunting. It was an obsession with me. I had 2000 acres of Georgia clear cut to hunt. The land held numerous coveys of Bobwhite Quail, and any given day, the dogs would find four or five coveys. Those two dogs and I would hunt from dawn 'til dusk 50-60 days every year. After a few years, we had the coveys named. I was the only bird hunter on the property. Life was good. Then, I read an ad in the Georgia Market Bulletin about "Have Fun With Your Bird Dog!", and "More Action per Acre!". The next weekend, I was in the north Georgia mountains, looking up a gently sloping field as a man rode a horse around the field dropping quail in the grass. I remember thinking, "How tough can it be? You have 30 minutes to find just five birds? And, they are all right there?" It did not go well for us. Rocket (Brit) found three birds pretty quick. I shot at and missed all three. He chased the last one into the woods, and I could hear him in there flushing that bird over and over again, as time ran out. The judge (on horseback, as well) said, "Don't worry, it'll get better!" I appreciated, but didn't need, his encouragement. I was hooked! That was in 1992.

Because my dogs were primarily hunting dogs, they were accustomed to near total freedom when I turned them loose. That was the crux of my problem- now, after all that freedom, the bird dogs had to learn a few things. For example, Ruby, the Setter, learned to back on her own. Rocket, on the other hand, didn't much care for

the backing thing, so I fought to keep him on the other side of the field during a trial. Many a time, I did the "walk of shame" with my leashed Brit as we were summarily ejected for interference. When a bird flew out of bounds, they both chased it. Then, I chased them into the woods and pulled them back into the field, reminding them all the while to stay in bounds. It was a constant battle. One I lost nearly every time. One opposing handler immediately understood the situation, and she would wait until Rocket saw her dog on point. Then, she would kick the bird near the judge, call safety, and watch my dog chase it out of bounds, while hers held steady. Then, she had the field to herself for at least ten minutes! It would have been easy to get frustrated and blame the judges, other handlers, the rules, everyone but myself. But, I knew it was me and my dog training. Those two dogs were replaced by others and things got marginally better. Many dogs later, I conceived the plan to raise a NSTRA dog from the start. I would teach them the basics to be successful in a NSTRA trial when they were young, when it was easy. All bird dogs, trial dogs or not, can benefit from field trial discipline.

NSTRA is not hunting. It's a game. But, it's a game that teaches a dog fundamentals, boundaries, limits, and obedience. It teaches them to quarter, to watch for other dogs, other handlers, to ignore outside influences, and to put a maximum effort into finding birds right off the line. In deference to the handler who would have my dog chase a bird out of bounds, my dogs are also taught what "leave it" means, and a low, guttural "Anch! Anch!" sound means "you'd better turn around RIGHT NOW!" Every single command I teach for NSTRA is applicable to bird hunting. Yes, there are other things they need to know (leave the Javelina, cows, porcupines, and skunks alone, and don't jump off 30' rock cliffs), but a NSTRA-trained dog can easily transition into bird hunting. The reverse is often, frustratingly, not the case. We have all seen it.

NSTRA is unique in that regard. It can be a life-long dedication to making a better bird dog. The result is a multi-purpose dog, that can successfully field trial one day, and point Bobwhites and Pheasant in a Kansas wheat field the next. Visualizing what you want the dog to be and training for the NSTRA field trail is a great way to start a dog on a lifetime of success in the field, whether on the trial grounds or on the prairie.





### Field First Aid 101

Hopefully as you read, weather is holding with a good outlook across the country for the remainder of bird season... if so make the best of it and get out there, you can read this later when the snow piles and the wind blows. If the snow and cold has you waiting for a lull, give it a quick read now, may come in handy.

Any case, not being an expert myself, I've gathered some practical information on "Field First Aid", stuff we need to know, some from books but mostly through talking with veterinarians who train and hunt with dogs... no big words just good solid information to help us better care for our dogs....

Not planning that any of us become clinicians only that we might recognize an emergency and know what to do as care for the small stuff or in preparation for transporting to the nearest veterinarian. We'll also point out items for a basic first aid kit and tips on preventative care while hunting and training.

#### TAILGATE INSPECTION

If you've followed any of my writing you'll know I highly recommend standing our dogs on the tailgate after each hunt or training session.. to look and feel them over, stem to stern, checking for cuts, bruises, grass-awns etc. A quick 'tailgate' check provide a way to find and care for the small stuff before it becomes 'big stuff'

#### VITAL SIGNS

Whether we're simply monitoring our dogs well-being during the hunt or as an attempt to appraise a more serious situation.

Being familiar with "vital signs" and how to monitor them are key, example; pulse, temperature, breathing rate, and what's normal in each case are essential indicators.

I suggest you read this section then practice on your dog, you'll gain confidence, accuracy and have a better idea of what's normal for your dog at different levels of activity.

#### **TEMPERATURE**

The average normal healthy dog's temperature at rest should be 101 degrees Fahrenheit plus or minus half a degree.

During or shortly after hard work it's not uncommon to find your dog's temperature at 104, 105 or higher, at this point most recommend you rest the dog and take measure to cool him.. while continuing to monitor temperature. After 5 to 10 minutes of rest you should see a drop towards normal body temperature.

In general, higher temperatures may indicate, heat stress or other disorders while a lower than normal temperature is often a sign of shock or hypothermia.

Temperature is taken with a rectal thermometer, before insertion be sure to lubricate it with petroleum jelly, lift and hold the dog's tail, while you insert the thermometer into the anus with a gentle twisting motion. The thermometer must stay in place until it indicates an accurate reading, during this time continue to hold the dog's tail and the thermometer.

#### HEART RATE

Normal pulse for an adult dog is 70 to 160 heartbeats per minute, while a puppy's may be up to 220. The easiest way I found to check pulse is on the Femoral Artery, it's the large artery that runs down the inside of the back leg.

Use your finger tips to locate the artery, high up near the center of the thigh where it meets the body. Although you can do this while the dog is standing, I like to lay him on his back. Once you've located the artery, I've found counting the number of heart beats in a fifteen second period and multiplying by four less of a battle than holding for a full minute and results in an accurate enough count for our purpose.

As I mentioned earlier, with practice you'll gain confidence and develop a feel of what's normal for your dog at various levels of activity.

Heart rate is a good way to monitor your dog's progress during exercise. In general, a dog in proper "field condition" has a lower heart rate during exercise and faster recovery times than do unprepared dogs.

#### RESPIRATORY RATE

Normal breathing rate for dogs range between ten and thirty breaths per minute. Check your dog and make note of what's normal for him. Realize that after activity panting at an accelerated rate is normal, take note here as well. Simply watch or feel his chest as it expands taking air into the lungs, count the number of breaths in a fifteen second period then multiply the count by four giving "respiratory rate" or breaths per minute.

An injured dog's respiration can be hard to determine, veterinarians suggest we hold a feather or tissue near the nose, so you'll notice even the slightest breath.

#### HOW TO MUZZLE A DOG

Pet care books and common sense recommend we muzzle injured dogs before tending to them. Even the best mannered and trained dogs will bite when injured often without realizing. So let's take some time to learn how to safely apply a muzzle.

Our concerns are keeping the dog from nipping or biting yet the muzzle shouldn't be overly tight... While muzzles are commercially available, a flat strip of cloth or gauze will do very well. Simply loop the material over the nose just behind the "K-9" teeth catching the lower jaw, bring the ends down under and make a half hitch to hold the jaws together. Next bring the ends around the neck just below his ears and tie off behind his head in a bow knot.

#### WOUNDS

A bruise or closed wound shouldn't be underestimated because the skin and hair coat may be intact, this type of wound can be deceiving. Whether caused by a direct or glancing blow, the full extent of



Quickly take measures to control bleeding and otherwise prepare the dog for immediate transportation to a veterinarian. (See control bleeding and shock)

If the chest cavity is punctured, identified by a sucking sound at the wound as air goes in and out, you have to seal it so the dog can breathe. Cover the area with a cloth and apply pressure until the noise stops then wrap with tape. If there's an object protruding from the hole, leave it for your veterinarian to remove.

While transporting, never give the dog food or water. Cover him to maintain body heat as a measure against shock.

#### SHOCK

Shock is lack of adequate blood flow to meet the body's needs.

The body is trying to correct this loss by speeding up the heart, constricting vessels and conserving fluid in circulation. If allowed to continue, vital organs begin to shut down for lack of oxygen, shock becomes self-perpetuating and can cause death.

Shock can be caused by dehydration, heat stress, infections, hemorrhage and related trauma. Some symptoms are a drop in body temperature, lethargy, cold extremities, pale gums and mucus membranes and a rapid but weak pulse.

Once diagnosed, remove the cause if possible, calm the dog and help him assume a comfortable position and cover him with a blanket while he's transported for help.

#### HEAT STRESS

Heat stress is often caused by a lack of common sense on our part, overworking fat or poorly conditioned dogs on warm days, not being attentive to fatigue, lack of water or shade, are examples, but the leading cause of death is the result of dogs left unattended in cars on warm days.

Early symptoms are less body and tail action, increased panting, As the problem progresses you'll notice aggravated panting, salivation, a panicky expression, the gums become dark red, and the dog has problems with coordination. All the results of elevated body temperature, our primary goal is to reduce body temperature.

When these symptoms are noticed, flush the mouth with cool water removing saliva and allowing the dog to drink small amounts of clean, cool water. Immerse the dog in cool water if possible or at least use wet rags, or available water to cool the under parts, most importantly mouth/throat and tongue. Cooling these areas cools the circulating blood which in turn helps to cool the brain and body core. In advanced cases, seek a veterinarian's assistance immediately ...

#### EYE CARE

Your dog's eyes should be checked periodically during the hunt, or at least at the end of each day. Weed seeds and debris lodged under the lids can cause irritation or eye corneal ulcers.

By carefully spreading the upper and lower lids you can see the entire eye. Pay special attention to the "third eye lid", It's actually a second lower lid, and the inside corners there is likely signs of trapped debris. If debris is present, try flushing it free with a stream of saline. If that doesn't

work, try to blot it out with a cotton ball soaked in saline. Caution: don't wipe, only blot softly, wiping can scratch the eye causing more damage. When the eye is cleared, you can apply steroid free antibiotic ophthalmic ointment.

If there's any question of damage or the material can't be removed, apply the ointment and see a veterinarian as soon as possible.

#### FIRST AID KIT

Before closing we have some suggestions on what you might want to have ready in a "First Aid Kit". Your veterinarian or pharmacy should have these items on hand. For a box to keep things organized a fishing tackle box works well.

Items should include a role of gauze, gauze pads, role of adhesive tape, betadine scrub, Betadine ointment, scissors, a nail clipper, forceps, saline solution and dispenser, cotton balls, q-tips, rectal thermometer, steroid free ophthalmic antibiotic ointment.

Hopefully this article will serve as an every day aid to maintaining your dog's health and well-being at home and while training and hunting, and you're never faced with severe problems.
