

# NSTRA MEMBERS - Important things to remember!

#### Reminders - check back often!

National trials are the responsibility of the National Officers with input from the Board of Directors and the local co-chairs of national trials. Criteria for entry, which may be subject to change, for the original 5 National Trials is available in the reference section of the Rule Book beginning on page 41, Section 11. If a particular national trial is subject to changes in the entry criteria, there will be notice provided on the official entry form, in the magazine, on the national website, and/or by email if available.

To enter a national trial, you may submit a hard copy official entry form and payment, OR you may scan and email an official entry form with payment information, OR you may send by facsimile and official entry form with payment information, OR you may enter and pay on-line on the website. NO EXCEPTIONS.

Please note that additional new national trials may be added from time to time and do not yet appear in the current Rule Book. Please contact your National Officer Representative or the National Office staff for additional information regarding such trials. The current list of National Trials is as follows:

**QUAIL FOREVER**, formerly known as Quail Invitational. This is a revolving trial generally held in February.

**TRIAL OF CHAMPIONS**. This trial is held in Amo, Indiana, in April.

NATIONAL AMATEUR TRIAL OF CHAMPIONS. This trial is held in Amo, Indiana, in April.

**UKC PERFORMANCE TRIAL**. This trial is a revolving trial generally held in June.

#### **PURINA ENDURANCE CLASSIC.**

This is revolving trial generally held in September:

**DOG OF THE YEAR.** This trial is held in Amo, Indiana, in October.

#### **TOP PERFORMANCE AWARD:**

To be eligible:

\*Dogs must have at least 20 open points accumulated in weekend trials between June 1 through May 31 of the applicable year. Once a dog is eligible, a schedule of scoring is applied based on the results at regional elimination trials and National Trials

\*The Performance Trial will be the

beginning national trial each year, even if it ends prior to June 1 in order to keep the number of national trials the same each year.

\*The Regional Elimination trial results used in calculating Top Performance Awards is the regularly scheduled regional elimination championship in the qualifying year/season (only one regional can count per year). Regionals scheduled or rescheduled to be held after June 1 will apply to the previous year. Each regional elimination will have a point value of 600 points. The value will drop 25 points per placement until the last dog or points run out (1 - 600, 2 - 575, 3 - 550, etc.). The placement for the regional eliminations is determined by the score of the last round in which the dog ran. In addition, 100 points will be awarded to the Champion, 75 for the second-place dog, 50 for the third and 25 for fourth.

\*The National Trials results are calculated as follows: A dog must place in the top 32 dogs to receive a qualifying score from that trial. Each national trial will have a point value of 800 points. The value will drop 25 points per placement throughout the Saturday cut (1 – 800, 2 - 775, 3 – 750, etc.). The placement for the national trial is determined by the score of the last round in which the dog ran. In addition, 100 bonus points will be awarded to the Champion, 75 for second place, 50 for third and 25 for fourth.

#### **HALL OF FAME NOMINATIONS:**

Hall of Fame nominations will be accepted in a rolling calendar throughout the year. Send these nominations to the nation office, or to a national officer no later than March 31 of the year in which a dog is to be considered. Nominations of dogs to the NSTRA Hall of Fame are NOT "carried over" to following years. Plainly stated, a dog that does not get elected to the Hall of Fame in the year nominated must be re-submitted in order to be considered for election. The National Officers, in concert with the Board of Directors, make selections to the Hall of Fame each April.

#### **TRIAL SCHEDULES:**

Fall/winter trial schedules are due in the office by May 1. Spring/summer trial schedules are due in the office by Nov. 1. All trials must be published on the website 4 weeks prior to their running.

#### **SANCTION FEES:**

Trial sanction fees are required BEFORE a trial packet is mailed and before a trial may be "approved" in the system. Please pay all sanction fees at least 4 weeks prior to your trial date to ensure prompt mailing of the packet and to ensure that the trial may be drawn in a timely manner.

#### **TRIAL REPORTS:**

Trial reports and results should be entered into the trial draw system as soon as possible after a trial and no later than 10 days after the trial date. Overall results will not be approved until the reporting is complete. First place points and championships will not be confirmed or awarded until the reporting is complete. (This includes receipt of all registration paperwork for placing dogs.)

#### **HOME REGION:**

Members requesting a change of Home Region must do so, in writing, through the National Office between the dates of October 1 and January 1.. \*Exception: A member who permanently relocates to within the boundaries of a Region, other than their Home Region, may make written application to the NSTRA office at any time to request a change in their Home Region.

#### **ASSOCIATE MEMBERSHIPS:**

Associate memberships are available to members' spouses and children 18 years and under, still living at home. There must be at least one regular paid membership in the household to qualify. Associate members have the same rights as regular members with respect to participating in field trials (e.g., owning dogs, handling dogs, judging, bird planting, etc.). Associate member may not vote in any regional or national elections including rule or by-law changes, they cannot hold an office, and they do not receive a magazine.

# Important things to remember

#### **RULE CHANGES:**

Proposed rule changes or new additions shall be submitted sixty (60) days prior to the first day of the Trial of Champions and/or the Dog of the Year trial.

# CONSTITUTION/BY-LAW CHANGES:

All proposed amendments to the Constitution and By-laws shall be submitted to the National Officers at least ninety (90) days prior to the first day of the Trial of Champions and/or the Dog of the Year trial.

#### **REGION HIGH POINT:**

Points earned in the qualifying rounds of a Regional Elimination or a Champion-ship trial DO count towards the region's high point competition. Points earned in the finals of above trials DO NOT count towards the region's high point.

#### **OWNERSHIP CHANGE:**

Once a dog takes a NSTRA placement, any subsequent ownership changes must be sent to the NSTRA office. Please send a copy of new registration papers with the new owners' names to the office. The date of transfer will be the date shown on the registration papers.

#### **UNREGISTERED DOGS:**

As of June 1st a dog cannot run in a NSTRA trial without a system-generated dog profile or record. A trial coordinator cannot create the record. National staff or officers can only create the record once registration papers are received in the NSTRA office. In addition, there remain many "unapproved" dogs in the system. Unapproved dogs shall not be entered to run in trials until proper paperwork is received and appropriate action to create the record is completed. This can either be submitted by the owner or the trial chairman. We will accept copies by fax (317-839-4197), e-mail (office@ nstra. org), or a photocopy by regular mail.

# NSTRA DISTINGUISHED MEMBERS:

The NSTRA Distinguished Members award honors those extraordinary men and women whose contributions and

achievements significantly helped develop, or continued to improve, the National Shoot to Retrieve Field Trial Association, Inc. This award will be presented annually at the Dog of the Year banguet. Nominations may be submitted at any time to the staff at the national office, to a National Officer, or to the current chair of the Distinguished Members Committee. A short description of the individual and their contributions to NSTRA should be sent to the national office. A picture of the individual should be included, if available. Contact the NSTRA office for a list of criteria. The committee will review all Nominations and verify contributions. Decisions will be made not only by the information submitted but by any other information collected. The committee will make their decision by the April Board of Directors' meeting. A permanent plaque will be located at the NSTRA office with a smaller plague awarded to the individual or their family if deceased.



# INTERVIEW WITH A WINNER Scott Townsend

1. How did you get started in NSTRA?

I was looking for something to do with my bird dogs other than testing them against a standard. I didn't want to compete from horse back. I was looking for something more closely related to hunting on foot. So, I came to NSTRA.

2. What was the name of your first dog?

My first NSTRA dog's name was Sarge.

3. Did you raise ?? from a puppy?

Yes, I raised him from a puppy. Most of the dogs I have trialed over the years I have produced at my kennel and raised from a puppy. But there have been a couple that I haven't. The current dog I'm running now I bought when he was one year old

4. Did you train ??? yourself?

I have trained every dog I have trialed myself. After competing in NSTRA for a few years I started training professionally.

5. How did you prepare for the TOC Championship?

I start preparing my dogs, besides working on their basic bird manners and handling, around four to six weeks prior to each national event. This training consists of gradually increasing conditioning program. It is extremely important to show up at the national events with a dog that is in top physical condition, especially going into that final day of the trial. To get to the finals your dog will have competed for an hour and a half and then they have to run another hour in the finals.

I routinely see dogs that run out of gas on their last day of competing due to lack of conditioning.

6. Which of the braces during the TOC week was the toughest?

It's been a bit since I competed in that trial but generally the toughest brace will be one of the braces in the last day of the trial. The dogs that make it to that last day are there because they are good, they have done their share of winning and don't make many mistakes. The same can be said for those dogs handlers.

7. When did you actually think you had a chance at the winning the championship?

If I got my homework done with the preparing of my dog, and he delivers good clean work on a consistent level. I am confident of winning any national event. There are lots of other factors that come into play to actually pull of the win, but showing up with a dog ready and capable makes me think I can win the event. There have been times when I bring a young dog that maybe lacks

the experience, but has the other tools, and I may lack some confidence; but the only way they learn is by getting out there and competing

8. Who has helped/influenced you the most in NSTRA?

That's a tough question because there have been so many people throughout my career with NSTRA who have influenced me. I have watched thousands of braces over the years and there is a winner and loser in each brace. We lose at this game way more than we win at it. Our format is such that you need to be able to deal with losing because more often that not we are faced with that fact.

To me being a humble winner and a gracious loser goes a long way in this game. I have always believed in letting your dog's abilities do your talking for you. Nobody likes a braggart.

Back when I started in NSTRA some of the true sportsman and fierce competitors who were tough draws and did a lot of winning, yet were always gentlemen and always respectful, were Anthony Crow, Bill Napier, and Lester Arnold--just to name a few. To me they were the epitome of what a true winner should be like. I'm sure I'm missing some others but guys like Neil Lessard, Sam Jones, Bob Cunningham, Bob West, and Jim Carter were class acts and extremely talented dog guys, who I always looked up to and respected.

9. What would you tell someone the best way to prepare for a championship trial?

Do your home work prior to showing up to a championship trial. Bring a dog that produces good clean bird work, a well as being in good physical condition. Most of our championship trials are held in warm to hot climates. A good conditioning program helps immensely. To me, a biddable yet driven dog, that handles really well is the key to success in NSTRA.

10. If you can think of any other questions you would like to answer, please feel free to add to the mix.

For those getting started in this game it's not easy. If it was everyone would do it. Keep in mind you are going to have some frustrating days, but as you and your dogs improve; it is extremely rewarding. Stick with it, seek out help to make yourself better. Judging goes a long way to improving you as a handler. You get a front row seat to others that are really good at the game and to see mistakes that are made. NSTRA is loaded with people that are more than willing to help you get in the game.

If I can be of any help, I'm happy to answer questions or offer advise if needed

# Ghosts By Randy Schultz



The truck was in sight. I had a few birds in the bag, and my legs were like rubber. Age was kind to me, but he was no gentleman. There was no, "Would you mind if I cut down on your endurance year after year?" or "Please remember to write everything down.", or "I'll have you standing in the kitchen wondering what you went there for? Just a reminder." No, he was no gentleman. It was the same every year, as I noticed tired legs, stopping to "catch my breath" while walking hills I would jog up in past years, and forgetting obvious facts and names. Even more telling, I noticed the young bucks I would hunt with were only making it up the hill the same speed as me. It struck me later they were waiting for me, kind of watching out for the old man- even Shelby, a friend's wife, and darned good hunting partner, would stop to "catch her breath". (Dang twentysomethings should learn to be a little more circumspect!) As I approach 70, I can see the faintest glimmer of the end in sight. Some days, it's a mere lightening of the sky. Other days, it's a lightning bolt in front of my face.

I was close to the truck now, and Pearl, my little Brit female, ran ahead to find the water

bucket I always leave out before the cast. I watched her stick her head down and drink greedily, and I was reminded of past dogs, gone many years, who'd done the same thing. Suddenly, Ace, my male Brittany, was right there. Lying down in front of the bucket gulping huge chugs of water, too tired to even stand, his big, powerful body was sucking in the fluid. He owned these Montana hills year after year. He was dead 5 years now, barely making it 10 years before the cancer took him. But, at that moment, I could see him and hear him. It was pleasant, but not- at the same time. I forced myself back to the present. I put a hand to Pearlie's head, and told her what a good girl she was, and that her dad would be very proud of her. Ghosts. Ace in that spot in Montana, or Wisconsin, Minnesota, Oklahoma, or Kansas. Old dogs, good dogs, brag dogs. They own, forever, patches of land all over the country.

The New Mexico sand hills and oil patch is not the prettiest place I hunt every year. It's smelly, hot, cold, windy, pokey, dry, slicker than snot, and will tear up a truck and tires. It is, most years, loaded with sand burrs, requiring a hunter boot the dogs every cast, and every plant or animal out there sticks, pokes, or bites. But, it is one of my favorites, and hunting it this year, I happened upon an area I remembered from 15 years ago. Bo, my setter male, ran off 3 days prior, and I'd combed the country talking to oil field workers, game wardens, even a live talk-show on the radio looking for him. Nothing, so far, but with all that hanging over my head, I still put a dog on the ground. Peaches was a big, white setter female. With a great nose, and a wonderful personality, she was a pleasure. She hit the sand and grit with a long stride and determination. We hunted a large circular course around several big pump jacks. She locked on to covey after covey that day. I swear she was doing her best to take my mind off my lost dog. My shooting was spectacular (for a rare change), and it took no time to bag a limit that day long ago. This day, I off-loaded Shack, my big, male Brit, and a litter mate to Pearl. I turned him out and, as he made his way over a dune, I remembered Peaches slamming to a point on the very top of that very dune, pinning a covey of Blues in the scrub just on the other side. I smiled as I buffed to the top looking for Shack. I was sort of hoping

he'd be locked up on the 7th generation of those Blues Peaches found years ago. It wasn't to be, but the thought kept Peaches with us that day, as Shack and I looped around the area. Her ghost was whipping that tail back and forth, slowing and, finally, locking up- her long, feathered tail straight up at 12 o'clock. Shack never saw her, but she was with us all day, off and on. Her spot in NM is where she was special. She's waiting there for me every year. Even if I don't show up in person, I can be there instantly with just a thought. Peaches. I smile when I remember driving down to Bronwood, in South Georgia, to get her out of a tremendous litter. What a nose she had!

Most of my days, now, hunting in North Dakota and Eastern Montana are spent behind my Brittanys. But, in the early years, my male setter, Bo, was my go-to dog. This year, I put Blue, a 2 year old Brittany, on the ground in a large Block Management area in Eastern Montana. As I looked up the gently sloping alfalfa field, it was easy to visualize old Bo cutting the field into manageable chunks and scanning the areas with his nose. He was not a beautiful setter. He had a tail with a bend over his back, but it never got high enough on point anyway. When he hit scent, he froze. Instantly! He would be twisted, front or rear low, head turned- an instant marble statue. It's not hard to feel the excitement, seeing him twisted like a pretzel, and knowing he doesn't make mistakes. Blue hunted his heart out, running big and fast, with the energy only a 2-year-old can muster. He never saw his older brother working right alongside him, coaching, suggesting, and leading him to the back of the field and a covey of Sage Grouse that stayed close to their lek just off the plowed area. The day, many years ago, when Bo first pointed them; he was 150 yards away. a white dot in the green. When I got to him, 5 huge birds lumbered into the air. I let them go, not sure what they were. They were the first Sage Grouse I'd ever seen. Later, I found out just how heavy they can be in the bird bag. Good, old Bo. My only "cover dog" and National Champion. I drive past that field almost every year, Bo long since gone, while scanning the hills for that flash of white. His ghost is still roaming the hills around that special spot.

It's difficult to return to several areas of the Wisconsin Grouse woods. Not because I physically can't, but because the memories are still too real. Ruby, my first and best Setter, was an amazing dog. Almost all white, with a little orange around her eyes, she was so classically beautiful on point, it took my breath away. I bought her because I wanted a dog with a little more range than the Brittany male I started bird hunting with. At 7 weeks old, driving back from Wade's farm in Tennessee with her curled up in my lap, how could I know I was holding the best bird dog I might ever have? She was perfect every day. When I decided to try hunting Wisconsin Ruffed Grouse, Ruby was there ready to go. I would open the crate door and ask her, "Ready for another day, girl?" She always was. Many years later, I took Shack and Cap, both accomplished male Brits, to the grouse woods. I stayed in the usual motel, drove the usual roads, and let out at an intersection of roads and trails deep in the National Forest. Both boys worked well. I had no complaints about them- just that they weren't Ruby. Her memory came on strong as I was walking the hunter trails. Her beeper (pre-GPS days) would go off, and I learned you'd better not hesitate getting to your dog in the thick woods, as the Ruffs would walk away from a pointed dog, and then flush when they fell comfortable. I got my first double on Ruff Grouse over her, and I re-lived it when I saw Cap moving through that area. He's no slouch as a bird dog, but, if he could have seen her moving through the woods with him, like I did, he would have known he was watching perfection. That little patch of clear cut is totally grown up now, but it will forever hold the memory of my all-white, perfect girl locked up on 6 Ruffs under a deadfall, just off the gravel road, deep in the Wisconsin North Woods.

Pretty much, they are all over the country. Idaho, Wyoming, Montana, North and South Dakota, Kansas, Oklahoma, Texas, New Mexico, Arizona, Minnesota, Michigan, Wisconsin, Georgia, Alabama, and Florida hold bits of dogs long gone but seared into my memory. So, I load up the dogs and ponder which of the current crew will leave their ghost behind to haunt me. Perhaps none of them, but I know that won't be the case as I see a flash of white through the trees, crossing the top of a ridge. I reach to my right to pat the head of whoever earned front seat privileges that day and hope to see my Ruby around the bend in the gravel road through the Wisconsin woods, one more time.

# The Hunters, they came

The evolutionary timeline of the dog dates back 60 million years. The following article is based on the most current data and theories regarding this evolution. We often say that hind-sight is 20-20. So, using our hindsight, where did our hunting dogs come from?

## **Symbiotic Relationship**

Man and dog, wonderfully symbiotic, like no other animals in the vast animal kingdom. What exactly does 'symbiotic' mean? A symbiotic relationship is a close association between two or more different species that exist together in a way that benefits them all. In other words, the dog benefits man, and man benefits the dog. Think about it. Why are we so closely bonded with our canine friends?

# **Taymyr Discovered**

#### Canine Bones Discovered in Taymyr Peninsula, Siberia

In 2010, on an expedition to Russia's Taymyr Peninsula, a rib was excavated from the riverbank where the permafrost had eroded away to reveal the remains of long-dead animals, such as woolly mammoths. On site, the rib was difficult to identify, so Love Dalén, an evolutionary geneticist at the Swedish Museum of Natural History in Stocklholm, who was on the expedition and co-led the study, placed it in a bag, marked 'reindeer?'

The initial sequencing proved that the bone was that of a wolf, and the radiocarbon dating indicated that the animal died around 35,000 years ago. The bone was identified as Taymyr Wolf.

This rib bone was a first of its kind, and it revealed the genetics of an ancient wolf—a new species of wolf that lived 35,000 years ago. The Taymyr wolf was studied in Stockholm University's lab by

Pontus Skoglund of Harvard University's genetics department, and biologist Erik Ersmark, Eleftheria Palkopoulou, and Love Dalén.

The assumption was that the wolf lived before any domestication had occurred. However, further testing was done of the genome (the whole of its hereditary information encoded in its DNA). The results were much different, "...the rib's genome indicates that the Taymyr wolf shares roughly equal ancestry with both modern-day domestic dogs and with wolves, suggesting that it lived around the time that the ancestors of today's dogs split from the ancestors of modern wolves." It

also lived around the time that man was a hunter-gatherer. And now, we have discovered the Taymyr, which answers many of our questions and gives us hindsight of the miraculous evolution.

**Man was a hunter-gatherer** approximately 2 million years ago until about 8,500–15,500 years ago. Hunter-gatherer culture is a type of subsistence lifestyle that relies on hunting and fishing animals and foraging for wild vegetation and other nutrients like honey, for food. Both species hunted game. The wolf had learned to hunt in packs, and man learned from watching the wolf. With similar lifestyles, is it any wonder that these two species came face to face?

Man and wolf shared a common landscape. Early man as well as subsequent hunter-gatherers watched as wolves followed the wild herds, stalked them, and steered them. Man undoubtedly learned better hunting techniques by watching the wolves. The wolf benefited when man killed more animals than wolves and discarded a lot of the kill. When wolves became dogs, their hunting partnership became intentional and bonding encouraged cooperation and respect. The early wolfdog probably initiated the process and crept ever closer to man's campfires and waste dumps. Man did more than tolerate the dog—he embraced and benefited from the dog. Both species evolved together in a relationship man has with no other animal on the planet.

Earth was going through some rapid climatic changes, which had an effect on the animal world. Long, long ago man and the wolf-dog began to work together for mutual benefit. No records have been found to document when this first began, there was no written word. However, we have uncovered much information. The bones tell us the story.

Greger Larson said, "Without dog domestication, civilization just would not have been possible." What was it that drew man and dog together? Biologists have analyzed this for many years. Two species inhabiting the earth, each becoming a master hunter, learning to hunt as a social group, learning to share. And in sharing the experience with each other, man and wolf-dog, becoming better. The wolf hunts its prey in groups, singling out a target, and chasing it until the prey tires. They then move in on the prey and attack. This is the point when the wolves are most vulnerable. Their prey will make a last stand and try to lash out with horn or hoof to protect itself. Man (with his opposing thumb) had the ability to craft crude spears which allowed him to attack prey from a distance. So, there you have it. The wolves targeted the prey, ran it down, and man made the kill. The wolves respected man as the dominant species and allowed man to harvest the meat from the kill. As soon as man had cut most of the meat off, the wolves were allowed to eat the remaining meat and to enjoy the bones. When the wolf started eating bones and socializing with man, they both began to change

As mentioned above, the bones tell our story. DNA, or deoxyribonucleic acid, is the hereditary material in humans and almost all other organisms. Nearly every cell in a person's body has the same DNA. Most DNA is located in the cell nucleus (where it is called nuclear DNA), but a small amount of DNA can also be found in the mitochondria (where it is called mitochondrial DNA or mtDNA). Mitochondrial DNA is the small circular chromosome found inside mitochondria. These organelles found in cells have often been called the powerhouse of the cell. The mitochondria, and thus mitochondrial DNA, are passed almost exclusively from mother to offspring through the egg cell.

When DNA is tested on any breed of dog, it is 99.9% the same as the now living gray wolf. What exactly does this mean? For years, we thought that it meant that our dogs had evolved from the gray wolf. But further studies have proven that this is not so. The gray wolf is a sister clade to the

dog. This means that the wolf and dog both evolved from a common ancestor. (Cladistics is based on three principles: 1. Groups of organisms are descended from a common ancestor. 2. At each node (divergence of a population), there are two branching lines of descendants. 3. Evolution results in modifications of characteristics over time).

In the book, <u>The First Domestication: How Wolves and Humans Coevolved</u>, Raymond Pierotti and Brandy R. Fogg looked to a source that "has been largely ignored in investigation of the evolution of the humans and their ecological relationships with other species: the solid information contained within accounts from Indigenous peoples around the world." Terms that the Indigenous peoples use to describe wolves are brother, grandfather, relative, companion, teacher and even "creator." This book goes on to cite many instances of stories from Indigenous people of coevolution, co existence, fine-tuning of the symbiotic relationship between man and dog.

# **In Summary**


The wolf and man formed a hunting bond during the 'Hunter-Gatherer' phase of man's evolution. The dog was the first animal domesticated and became man's hunting partner. In fact, some biologists think that it was the dog who domesticated man instead of the man domesticating the dog. With more successful hunting, human population could thrive and grow. It's almost as if the dog evolved to be the helpmate to man to insure their (man and dog) survival.






